## The Evidence of a Rewritten History: An Exploration of Cataclysms and Historical Manipulation By Michael McKeon VII Grade (5/26/24) Woodland, CA

Over the past two decades, my research, alongside that of several colleagues, has focused on evidence suggesting the occurrence of repeated cataclysms, which may have been exploited by certain agencies to alter our historical narrative. It is posited that a millennium was added to our timeline, obscuring a recent event by pushing it into the distant past. This manipulation may have facilitated a re-education of the population that emerged after these cataclysmic events.

Researchers have pondered the rationale behind the addition of this thousand-year period. Notable figures, such as Isaac Newton, who authored two relevant works, and Russian mathematician Anatoly Fomenko, who has published seven books on the subject, have argued that this temporal discrepancy exists. Historians attribute this accumulation of dirt to "cultural layers," suggesting that residents were simply negligent in maintaining their sidewalks. However, this narrative is met with skepticism.

Similar evidence can be found in cities such as London, Moscow, and Cincinnati, where partially buried structures reveal first-floor windows jutting above ground. Historians often claim these windows served to illuminate basements, yet upon investigation, these basements resemble the original first floors.

Another avenue of this research involves the phenomenon of the "reset population." Between approximately 1854 and 1929, orphan trains relocated an estimated half a million children from Europe to the United States and Australia, distributing them to families eager to adopt.

A related aspect pertains to the large numbers of adults housed in insane asylums, which some contemporary historians speculate were individuals who resisted the new historical narratives imposed on these children.

Notably, photographs from the Industrial Revolution predominantly feature children, who represent this reset population following the cataclysmic events of the early 1800s.

Additionally, the magnificent megalithic structures across North America and other regions raise intriguing questions. Many of these buildings, including state capitols, post offices, city halls, and churches, appear to have been constructed by a prior civilization that was subsequently obliterated. However, the profiles of these architects—often young and uneducated— raise doubts about this narrative, leading researchers to believe these structures were built by a previously advanced civilization rather than by the architects credited in historical accounts. Visual evidence from the Civil War period depicts horse-drawn carriages before these grand edifices, suggesting a discrepancy in the timeline of construction.

Moreover, the World's Fairs of the late 19th and early 20th centuries, traditionally characterized as temporary exhibits, appear to showcase the architectural brilliance of the preceding civilization. Many researchers propose that these fairs functioned as indoctrination and repopulation centers, akin to Ellis Island, with admission tickets resembling passports containing personal information.

Curiously, the great fires that ravaged cities like Boston and Chicago left thousands of buildings in ruins, yet reported fatalities were minimal. The destruction often involved primarily stone structures, leading some to speculate that these events resembled bombings more than typical fires.

This ongoing destruction of evidence appears to be a systematic effort to obscure the legacy of an advanced civilization that preceded our own.

Consequently, we must ask: Why has this evidence been suppressed, and what is the intent behind the addition of a millennium to our historical timeline? What truths are the world's controllers attempting to conceal?

Today's researchers have proposed a compelling hypothesis: Preterism suggests that the millennial reign of Christ has already occurred.
